## NANAIMO MINOR HOCKEY ASSOCIATION BENCH STAFF CONTRACT (CODE OF CONDUCT)

The purpose of this contract (Code of Conduct) is to promote fair play and respect for all participants within Nanaimo Minor Hockey Association. All bench staff is required to sign this contract before participating in hockey and must continue to abide by the principles of Fair Play.

### **FAIR PLAY CODE**

1. Bench staff, for the purpose of this contract, is everyone that has a hand in the day to day running of the team (All coaches, managers, safety persons and “Den Mothers” in the case of the female teams). Bench staff must be up to date with their Respect in Sport, have an updated Criminal Record check done and verified, as well as any coaching courses done by the required dates. THIS DOES NOT INCLUDE PARENTS.
2. As a member of the bench staff, I will accept the Fair Play rules set out by Hockey Canada. (If you are unfamiliar with them please look them up on the Hockey Canada website)
3. As a member of the bench staff, I will abide by all policy and procedures set out by Hockey Canada (HC), BC Hockey (BCH), Vancouver Island Amateur Hockey Association (VIAHA), and Nanaimo Minor Hockey Association (NMHA). These policies are available for viewing on each association’s websites.
4. As a member of the bench staff, I will support ALL EFFORTS to remove ALL physical and VERBAL abuse, including that of ON ICE OFFICIALS for ALL hockey games and practices.
5. As a member of the bench staff, I will abide by the two deep rules (which mean that there will be two members of the bench staff in the dressing rooms at all times).
6. As a member of the bench staff, I will ensure that there are qualified people at the arena at any time there are players present in the dressing room. (If it is the coaches policy is to be at the arena 30 minutes before a game then there has to be bench staff in the arena and in the dressing rooms at that time and there must be bench staff present until the last player leaves the dressing room).
7. As a member of the bench staff, I will never publicly question the honesty or judgement of the Officials. I recognize that the Officials are being developed in the same manner as players. DOING SO GOES AGAINST ARTICLES 2 AND 3 OF THIS CONTRACT, AND MAY RESULT IN DICIPLINARY ACTION BROUGHT AGAINST ANY MEMBER OF THE BENCH STAFF, UP TO AND INCLUDING REMOVAL FROM THE TEAM ROSTER.
